



TERMS AND CONDITIONS

I. INTRODUCTION

These Regulations were made on the basis of legal provisions in force in the Polish territory, and subject to its regulation of the conditions of use and operation of an Internet Portal FUN4TWO.NET located at the Internet address <http://www.fun4two.net> Rules set out the rights and obligations of registered users of the Service, and the rights, duties and responsibilities of the Administrator as the manager and operator of the Portal. II. STATEMENT OF AGE OF MAJORITY

- You warrant that it will not use the portal in order to intimidate or harass other people, and will not undertake actions that would have to damage, overburden, or deterioration of the portal.
- You are fully responsible for the use of your account and commits to appropriate safeguards against access by third parties to access data portal. You agree not to share their data access to the portal to third parties. Any attempt to access your account by third parties should be immediately reported to the Administrator of the portal. Portal is not responsible for any loss of your person caused by any unauthorized use of your account but you may be liable for losses relating to the Portal or others due to such unauthorized use.
- User must provide true information when registering an account and declares that it will not impersonate another person. You must update the data contained in the portal whenever such change occurs.

systems, servers and Internet connections. Administrator Portal in no way responsible for any loss resulting from the use of the Portal.

- The administrator is not responsible for materials that are published by users of the Portal and for losses resulting from the publication of the above materials,
- You represent that neither he nor his heirs will not put forward any claims against the Administrator of the portal under the incurring of any damage or loss allegedly arising from the use of any published or viewing on the Portal content.
